## The What

- Work-Based Learning (WBL): WBL is a school-coordinated, sponsored, coherent sequence of workplace experiences that are related to each students' career goals and interests, while based on instructional preparation, and are performed in partnership with local businesses, industries, or other organizations in the community.
- WBL enables students to apply classroom instruction in a real-worksite environment.
- WBL can be integrated with identified core academic coursework, career and technical education curricula, identified local board approved course(s), or electives to support strong secondary and postsecondary education opportunities that prepare students for mid- and high-level skilled careers in the 21st century. Students completing a well-defined program with competency framework will be better prepared to enter the workforce, military, and/or pursue postsecondary education and meet the <u>Profile of the SC Graduate</u>.

# The Why

### **Accountability**

Work-Based Learning is tied to the state's accountability system for college and career readiness, positively affecting report card ratings. The career ready qualifiers are apprenticeships, internships, or co-ops.

#### **Funding**

Perkins Federal and SC State EIA funding is tied to yearly reported WBL numbers. Allocations are released each year to each district for the purpose of WBL implementation.

### Workforce Ready

Students learn firsthand workplace readiness skills and expectations of employment; labor market demand, real life, real work, real world situations to compete in global economy.








### WBL Career Ready Roadmap

 1. Student is placed at worksite!
(must be apprenticeship, internship, or co-op) 3. Student must have earned a minimum 1 unit of credit in pathway related to placement 5. Industry evaluation plan is created from training agreement, scale 1-5, aligned to Profile of SC Graduate (final evaluation 3 or higher for career ready)





7. Report placement in PowerSchool on the WBL page in the RED box!



2. Placement must be aligned to student's IGP/Career Goals

 4. Training agreement is created with worksite supervisor outlining objectives and skills to be mastered during placement. (Min. 40 hours to qualify) 6. Student

successfully completes the entire placement



### WBL Experiences and WBL Career Ready Qualifier Reminders

#### Documentation

All WBL Career Ready documentation is maintained at the school level for two years after the student graduates from high school. Documentation includes IGP at time of placement, training agreement, and evaluation plan.

### Compensation

Compensation as a paid or non paid student during placment is districtspecific decision in coordination with sponsoring worksite.



#### Liability

Liability is a district-specific decision in partnership with the sponsoring worksite. Check with legal team on certificate of coverage. Check with business on workers compensation if student is paid for placement.

### Implementation

WBL Implementation is school specific process. Refer to principal, supervisor for guidance on WBL offerings, partnerships, and collaborations internally and externally.

### **Academic Credit**

Academic credit is district/school specific decision based on course offerings and WBL implementation. Course offerings may vary based on program of study. Academic credit could be tied to a state or local board approved course.

### Reporting

All WBL experiences and/or WBL career ready placement must be reported in PowerSchool on the WBL page. Career Ready is reported in the RED box. All other WBL experiences are reported below the red box.
